Immigration History

On June 20, 2023, Mr. BRUTUS arrived at the Hidalgo Port of Entry in Hidalgo, TX without documentation required for lawful entry into the United States. U.S. Customs and Border Protection (CBP) served him with a Notice to Appear pursuant to Section 212(a)(7)(A)(i)(I) of the Immigration and Nationality Act. CBP subsequently paroled him into the United States, pending removal proceedings.

On June 23, 2023, Mr. BRUTUS filed an Application for Employment Authorization, Form I-765, with U.S. Citizenship and Immigration Services (USCIS).

On September 21, 2023, USCIS approved MR. BRUTUS' Application for Employment Authorization, Form I-765.

On November 19, 2025, ERO Newark encountered Mr. BRUTUS while he was detained at Union County Jail, in Elizabeth, NJ, and lodged an Immigration Detainer - Notice of Action, Form I-247A.

On December 11, 2025, Mr. BRUTUS entered ERO Newark custody, pending removal proceedings.

On December 12, 2025, ERO Newark transferred Mr. BRUTUS to Delaney Hall Detention Facility (DHDF), in Newark, NJ.

Criminal Record

On July 9, 2024, the Elizabeth Police Department (EPD) in Elizabeth, NJ arrested Mr. BRUTUS for criminal trespassing. This charge is currently pending.

On August 24, 2024, EPD arrested Mr. BRUTUS for criminal trespassing. This charge is currently pending.

On November 19, 2025, EPD arrested Mr. BRUTUS for criminal trespassing. This charge is currently pending.

On November 28, 2025, EPD arrested Mr. BRUTUS for two counts of criminal mischief – damage property. These charges are currently pending.

On December 12, 2025, at approximately 1:25 p.m., a registered nurse (RN) completed Mr. BRUTUS' intake screening, using a Creole interpreter, documented normal vital signs, his denial of any past medical history, and cleared him for general population.

- **On the same date**, a custody officer announced a medical emergency when Mr. BRUTUS became sluggish and began hyperventilating while he was being escorted to his housing unit.
- **At approximately 4:28 p.m.**, medical staff and a custody officer responded to Mr. BRUTUS' housing unit, noting he was in distress.
- **At approximately 4:32 p.m.**, a custody officer called 911 and requested emergency medical services (EMS).
- **At approximately 4:42 p.m.**, health staff initiated cardiopulmonary resuscitation (CPR).
- **At approximately 4:45 p.m.**, health staff administered naloxone to Mr. BRUTUS intranasally.
- **At approximately 4:48 p.m.**, a staff member arrived at the scene with an automated external defibrillator (AED).
- **At approximately 4:50 p.m.**, EMS personnel arrived at the scene, assumed Mr. BRUTUS' care, and continued CPR.
- **At approximately 5:03 p.m.**, EMS personnel departed the facility and transported Mr. BRUTUS to the University Hospital (UH) emergency room. [
- **At approximately 5:45 p.m.**, a UH emergency room physician pronounced Mr. BRUTUS deceased.
